

#### **Terms & Conditions**

These terms and conditions ("Promotion Terms and Conditions") govern the Emirates NBD Bank P.J.S.C. ("Bank" and "Emirates NBD") for Marriott Bonvoy Credit Cards Limited Time Offer. The Bank shall not be liable for any losses resulting from the fluctuation of foreign currency exchange whilst converting the Eligible Spends to AED.

The Bank shall not be liable for any personal injury; any loss or damage (including loss of opportunity), whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Bank's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Bank) due to any reason beyond the control of the Bank; (d) any tax liability incurred by a winner under this Promotion; or (e) use of a prize.
