



CIO OFFICE MORNING MARKET WRAP – Thursday 4th February 2021. ALSO AVAILABLE ON ALEXA.

A strong February so far with most global indices back in the green and global equities up 2.6% year to date. Investor sentiment is positive with lower rise in virus cases and more vaccine candidates getting approved, improving global availability. The trading frenzy surrounding shares shorted by hedge funds has subsided as of now. Global equities rose for the third trading day in February with positive returns from the US, Europe and Asia. A risk on mood in February so far with Emerging market equities gaining 4.8% and developed market equities +2.9%. UAE equities slightly down yesterday, by 0.4% but still at strong 10% plus year to date gains. The Indian Sensex Index closed above 50,000 for the first time, taking February gains to over 8%. On the global sector front energy led gains as oil continued its ascent with Brent futures this morning at \$59/ barrel. The technology sector saw a small drop though Google shares gained 7% post strong results and the market cap is at \$ 1.4 trillion, on its way to catch up with the 2 trillion plus market cap of Apple.

This morning Asian equities are trading slightly lower to flat. US 10-year yield is at 1.146% and the yield curve is at its steepest level in almost 6 years. The Vix Index is at 22.9 a little above the average since 1990 of 19.5. Gold is lower at \$1823. However,

volatility will be seen as the year progresses as the recovery trade has gone a long way and many risks persist. Yet we think equities will continue to move higher. Growth remains supported by monetary and fiscal policy and stimulus and overall positioning is still not stretched.

The Stoxx Europe 600 index is up 2.9% so far this week. Italian markets rallied on hopes that former ECB chief Mario Draghi can bring political stability to Rome. He has accepted a request from Italy's president to attempt to form a national unity government after attempts to revive a coalition led by former PM Giuseppe Conte collapsed this week, leaving the country lacking a stable government. The Eurozone economy shrank less than expected in Q4 2020, with GDP contracting by 0.7% q/q for a 5.1% y/y decline, according to initial flash estimates from Eurostat. Estimates also showed that GDP fell by 6.8% y/y in the euro area and 6.4% y/y in the 27-nation European Union for 2020 as a whole.

Globally 105 million vaccine doses have been administered and the UAE remains in the lead with over 35% of the population vaccinated. The U.S. is now averaging over 1.3 million doses per day and that number could increase once the Johnson and Johnson vaccine receives emergency use authorization. On the macro calendar the 174,000 gain in the ADP's measure of private payrolls indicates that, following a step backwards in December when payrolls fell by 78,000, the labour market recovery recommenced in January. PMI Composite for January was also better than estimates: 58.7 vs 55.5 estimated. PMI Services reported 58.3 vs 54.3 estimated and ISM Non-Manufacturing for January was 58.7 vs 56.7 estimated.

The Bank of England sets rates on Thursday and an Indian central bank policy decision is due Friday. The U.S. January payrolls report is due Friday.
