



## CIO OFFICE MORNING MARKET WRAP – Tuesday October 6th, 2020. ALSO AVAILABLE ON ALEXA.

What a difference a couple of days make. Sunday it seemed still justified to have doubts about whether markets would be focusing on political uncertainty in the wake of the president's hospitalization or rather starting to believe that fiscal stimulus from Congress is a step closer and cheering that prospect. Judging from Monday's price action it looks like investors have embraced the notion that more big money will be spent in the US further down the road. The S&P500 closed 1.8% higher, dragging Europe along, +0.9%, while crude prices reversed course to gain over 5%.

It is remarkable that US 10-year nominal and real yields jumped higher alongside market-implied inflation. Taking into account that also material large-cap stocks outperformed, one would be tempted to conclude that investors are starting to skew their bets in favour of a Biden win, if not a so-called blue sweep, a scenario where Democrats would be holding control both of the presidency and Congress. A democratic sweep would imply larger federal deficits and more Keynesian policies, whereby public money would be used to foster job creation, in particular via infrastructure expenditure.

Indeed, financial conditions had recently started to tighten with peak monetary stimulus reached when Powell failed to add new measures at the September meeting. But that becomes less relevant if expectations of fiscal support from Congress sooner and of increased public expenditure later, gain traction. Actually, a clear-cut Democratic victory could be the fastest way for Powell to achieve the long sought-after 2% inflation target and actually overshoot it, by combining the power of outsize monetary and fiscal policies.

We will soon get to know whether these conjectures will become reality, or President Trump rather will manage once more to reverse the polls as he did in 2016, this time by recovering from its ailment at lightning speed and eliciting voters' compassion. The Romans used to say that All Roads Lead to Rome, and it looks like that Rome is embodied by ever larger public debts and that these roads are now being even treaded by supranational institutions like the International Monetary Fund.

The IMF Monday called on the governments of rich countries to increase investments to sustain the recovery, especially by focusing on infrastructure maintenance. According to Goldman Sachs Saudi Arabia is budgeting for Brent crude to be around \$50/bbl for the next three years. The Kingdom, typically conservative about future price estimates, does not disclose its assumptions, leaving it to analysts to infer the implied price projections.
