



CIO OFFICE MORNING MARKET WRAP – Sunday 10th of May, 2020. ALSO AVAILABLE ON ALEXA.

Last week's most spectacular number was the US unemployment rate which reached 14.7% in April. It is the highest since 1940, and to compare with the world before covid19, it was 3.50% back in February, a 50 years low. The US labour market is known for its flexibility, but it is worth noting that 80% of unemployed Americans in April were temporarily laid off, and that the 20.5mn job losses were slightly better than expectations.

This confirms that the focus is on reopening the economy, and explains why risk appetite was actually high on markets on Friday. Global stocks rose 1.4%, pushing the weekly return close to 3%. Rates were slightly on the rise, with the US 10-year Treasury yield increasing 4bp to 0.68%. The price of Brent crude oil moved up 5%, approaching \$31. European lockdowns are being gradually lifted, starting Monday for example in France and the Netherlands.

The UK will release its official plan today for a reopening expected to start in June. The next and most important for the global economy is the US, where the daily growth in new covid19 cases is stable at 2%, and where pressure is mounting to relax the restrictions.

The latest example is the reaction of Tesla's Musk, threatening to move its operation away from California as he was blocked from reopening his only US based plant. Geopolitical tensions are also not far away: President Trump told Fox on an interview that he was having very hard times with China, and was considering punishing Beijing for the virus outbreak.

This came in sharp contrast with the recent remarks from his administration earlier this week. Having said that, last week's biggest positive surprise was the rise in China's exports last month, which confirmed its recovery and gave markets comfort on the fact that April should hopefully have been the worst month of the current crisis.

As we write this Sunday morning, financial markets are closed but Bitcoin is down more than 10%, weighing on all crypto assets, after having doubled in the last six weeks and only days before an important change in its supply mechanics. As the fixed income futures markets are still pricing in the possibility of negative rates in the US in the near future, attention for alternative stores of value is on the rise, which is one of the reasons why we overweight Gold.
