



CIO OFFICE MORNING MARKET WRAP – Monday October 12th, 2020. ALSO AVAILABLE ON ALEXA.

Last week was excellent for global assets, and our regional markets also gained yesterday, led by KSA, up 1.2%. Consolidation in the bank sector is gearing up there with National Commercial Bank finalizing their offer to buy Samba Financial for \$15 billion. This is a modest 3.5% premium to the last share price but talks were ongoing for several months. The combined entity's total assets should near \$220 billion.

In Asia this morning, Chinese policy makers have removed constraints to short the offshore yuan, in a move aiming at limiting its strength. When authorities speak, traders listen: as we write, the yuan is down 0.7% against the dollar, which is also ticking higher against major counterparts. Chinese stocks benefit from the move, with onshore indices up 2.2%, also helped by possible announcements from President Xi Jinping to support foreign investments further, during a visit to Shenzhen planned later this week. Hong-Kong follows, up 1.5% as we write, and South Korea gains 0.5%.

Developed Markets are more mixed: the Nikkei is down 0.3%, negatively affected by the dollar strength, and Australia is flat. Western futures are fluctuating without a clear direction, taking a breather after last week's rally. The US stimulus bill remains crucial for short-term market direction, and the contradictory newsflow continues. Given the electoral context, it's basically a blame game: President Trump said his administration is "having a hard time with the House speaker Pelosi", who in return blames the Republican for a "miserable and deadly failure". At this stage, let's assume that no deal will be inked before the future tenant of the White House is known, and keep the low probability of a good surprise. Fiscal stimulus now would be of great help, but 2 more months before it happens should not make a

tremendous difference for the big picture as long as markets are confident it will ultimately happen in size.

Meanwhile in Europe, positions harden between the EU and Brexit, with French President Macron saying that no deal is better than a bad deal and Mr Johnson reiterating he is prepared to walk away. On this one we would take a slightly optimistic stance: as surprising as it sounds, verbal escalation is historically often an indication of progress on negotiations in the EU. Their ultra-complex decision making process usually requires to titter the edge of the abyss to trigger action. The UK had set a deadline on October 15th for an agreement, but it is unclear whether this cannot be extended – we tend to think it will.

This week will be rich in company news, with the Q3 earnings season really starting with US megabanks. Apple will hold their seasonal keynote tomorrow, with the expected release of the latest iPhones. Political news flow will keep on driving markets' mood, even if Mr Biden's current double-digit lead in the polls should make the "blue sweep" a central scenario. The second presidential debate is also scheduled at the end of the week. Nevertheless, we will focus on the fundamentals, should it be signs of resilience in corporate results, data on China trade, and the German ZEW indicator.
