



CIO OFFICE MORNING MARKET WRAP – Monday June 15th, 2020. ALSO AVAILABLE ON ALEXA.

Markets experienced their first significant correction last week since the rally began in late March, but Friday session was positive, signalling some dip buying. Virus anxiety came back, at a time when the momentum of incremental good news on the economy and policy response is logically starting to fade.

We have decided to start reducing risk in our recommended allocations last week: we cut our allocation to equities to underweight, but also partially re-allocated to high yield bonds, getting closer to neutrality from our previous large underweight position. Our underlying scenario is unchanged: the global economy is recovering, we don't expect renewed generalized lockdowns, but the pace of the recovery may not be as quick as stock markets are currently anticipating.

This is why we have reduced our positions in stocks, without going outright defensive. In addition, the massive liquidity injections from central banks and the partial but material recovery in oil prices made us reconsider high-yield, where the risk is high, but adequately remunerated. In a nutshell, we expect significant volatility for the medium term, which could provide opportunities to increase exposure on more reasonable valuations. The short-term

will be driven by news flow and investors' positioning. On the latter, we believe that most of the bearish capitulation is coming to an end as we approach the end of the quarter and the expiry of derivatives. On news flow, the risk factor is clearly a resurgence of infections, as well as any material disappointment on economic data. The virus developments are not encouraging today, with two fruit and vegetable markets in Beijing being locked down as well as 20 residential compounds of the political capital.

The official number of new cases is not spectacular in absolute at 60 but it is taken seriously, with an explicit warning from the country's vice premier. Tokyo also reported 47 new cases, its highest number for one month. Even more important for markets are the USA where 20 states are seeing a pick-up, and where expert Dr Fauci suggested that bans on travel to the US may remain relevant until a vaccine arrives. Such news are of course scary, however the number of cases is still limited and our collective capacity to contain and treat them has dramatically improved compared to the early stages of the outbreak.

Our scenario doesn't include a massive second wave, and certainly not the global economy to be halted again. On the economic front, news are not so bad. China continues to recover rapidly. The industrial production for May released this morning shows a +4.4% year-on-year increase, below 5% expected by the consensus but still an acceleration after the already robust +3.9% of April. We are not far from the end 2019 level in absolute. Retail sales are still down -2.8% year-on-year but also improving after -7.5% in April.

The world's second largest economy is doing well, and the fate of the world's largest will largely depend on consumer spending. The US retail sales of May, released tomorrow, is expected at a robust +8% month-on-month. We will know what the US consumer will do with the money he saved in April, where the savings rate reached an all-time high of 33%. In the meantime and as we write, markets are clearly negative in the early session of Asia, dominated by this second wave risk. Hong-Kong, Australia, Japan and South Korea are all losing around 1%, while US future contracts on the S&P500 are down 1.3%. In a typical flight to safety, the US dollar is stronger and the US 10 year treasury yield is lower at 0.66%. Energy prices are obviously also affected with the current future contracts on Brent crude losing 2%, just below \$38. We will see if the first negative week in a month for oil prices will trigger any reaction from the OPEC+ technical committee which meets Wednesday. In the meantime, Fed chairman Jerome Powell will deliver today his semi-annual policy report to congress. We don't expect anything different from the press conference of last week where the most important sentence was: "we are not even thinking about thinking about raising rates".
