



## **CIO OFFICE MORNING MARKET WRAP – Thursday September 16<sup>th</sup>, 2021. ALSO AVAILABLE ON ALEXA**

Optimism dominated US markets on Wednesday. After several mixed sessions, the S&P500 closed up 0.9%, taking the opposite direction of its European and Japanese peers, while emerging markets were little changed on average. Our local markets did well, with Dubai flat and Abu Dhabi up 0.8%, lifting their year-to-date returns of respectively +16% and +55% so far - a very bright spot within the emerging market universe. Interest rates were modestly firmer, with the US 10-year Treasury yield adding 2 basis points to 1.30%. Action was in the energy sphere, with natural gas prices recording a double digit jump intraday – year-to-date progression for the UK based ICE future contract is now close to 300%. Oil was also very well oriented. The price of Brent crude added 2.6% to close above \$75.5, after a confirmation that US stockpiles have tumbled: storms in the Gulf of Mexico have added disruption to an already tight market.

No doubt, inflationary pressures are here but they are overall not accelerating – with energy being an exception. As per growth, it's the opposite: the loss of momentum linked to the delta variant is material. Manufacturing activities remain however relatively resilient, as shown by yesterday's jump in the Empire manufacturing survey, from 18.3 in August to 34.3 in the latest release. Consumer related activity is clearly slowing, but it is by nature more versatile and could rebound strongly with better virus control. On that topic, both Pfizer and Moderna explicitly admitted yesterday that the efficacy of their mRNA-based vaccines fades over time. This supports the idea of an additional booster shot, which was also recommended by an Israeli study which concluded that the infection rate for people who had a booster shot was 11 times lower than for others.

As we write this morning, most of Asian stocks are down, except for the energy sector. Asia overall is net importer of oil, and market participants also have to digest two key concerns. First, Evergrande's mountain of debt will certainly be imminently restructured, in an orderly but painful manner. Second, the regulatory overhaul from China shows no respite, their latest target being Macau casino sectors. Stocks are down -1% in Japan, Korea and onshore China but -2% in Hong-Kong. Interest rates are unchanged and oil prices continue to rise, along with natural gas futures.

In other news, UAE's senior leadership is visiting Europe. In the UK today, an investment of 10 billion pounds over 5 years from our country was announced, which includes clean energy, infrastructure and technology. On the other side of the Atlantic, the US House Ways and Means Committee approved the majority of the large set of tax increases proposed by the Biden administration, focusing on corporations and wealthy individuals. No republican voted in favor this is important step in the process of making Biden's multi trillion long term economic plan a reality.

Today we will focus on the US retail sales for August which are expected by the consensus to be down -0.7%. If we had to bet, we would say that risk is on the upside. We will also have a look at the weekly initial jobless claims and listen to a speech from the ECB President Mrs Lagarde. Friday could be volatile as it is a "quadruple witching" day on US markets, meaning that options and future contracts will expire on four different kind of assets. This means higher volume and potentially amplified intraday moves. Stay safe.
