



CIO OFFICE MORNING MARKET WRAP – Wednesday 17th February 2021. ALSO AVAILABLE ON ALEXA.

Yesterday was quite eventful, not so much for equities, which closed mixed to little changed depending on geographies and markets, as for bonds. US 10-year yields closed at a one-year high adding 11bp and real rates slightly more than half that. Oil emerged pretty unscathed, while gold could not take the burden of stronger rates and slipped closer to key support levels.

The Treasury market is reacting to Biden's push for a \$1.9tn package, which is "admirably ambitious", but "brings some risks, too", as Larry Summers, ex Treasury Secretary, put it. We have been waiting for quite a while for this moment, which is now approaching quickly, the approval of sizeable fiscal relief measures by Congress, expected to occur by the end of March. The new flow of money will ultimately increase the purchasing power of the final recipients straight off, fast-tracking the boost to economic growth that monetary policy alone could not achieve. Summers recently remarked, on his Washington Post column, that while "the Obama stimulus was about half as large as the output shortfall, the proposed Biden stimulus is three times as large as the forecast shortfall", making a comparison with the 2009 Obama rescue measures. Treasuries are duly taking notice and most likely rates will be headed still

higher, before coming back later this year. By the same token, the cyclical impulse engineered by Congress could be a short term positive for the US dollar, in spite of the growing longer term headwinds for the global reserve currency due to the swelling federal debt. Record-freezing weather disrupted oil exploration and production in the United States, cutting north American output by almost a third and causing power outages in Texas. This cold spell in the northern hemisphere provided a bigger-than-expected boost to oil consumption at a time when stockpiles were already declining. While it's unclear how long the bad weather will last, the impact on global crude prices should be short-lived.

Supply curbs of a different nature could come from China, as Beijing is exploring limiting shipments of rare earths to affect the US defense industry. Rare earths are minerals central to producing weaponry, but also smartphones, electric vehicles and wind turbines. Although China has an absolutely dominant position in this kind of production, the Chinese authorities are aware that restrictions should be exercised with care, as they could spur a rush to increase the capacity of rivals and dent their existing dominance. For now rare earths remain a source of friction in the already tense China-US relations, especially since the United States have continued to maintain close ties with Taiwan being frowned upon by China.
