



# CIO OFFICE MORNING MARKET WRAP – Wednesday June 17<sup>th</sup>, 2020. ALSO AVAILABLE ON ALEXA.

Tuesday was an excellent day for financial markets. Global stocks rose 2.4%, with the US gaining 1.9% and Emerging Markets an average 1.6%. Dubai, Abu Dhabi and KSA major indices added between 0.6% and 1.4%, and the price of Brent crude oil moved up 2.6% to \$40.8. The US 10 year Treasury yield added 3 basis points to 0.75%. The message is clearly an improving outlook.

Indeed, yesterday's important US retail sales report for May didn't disappoint with a 17.7% increase from the prior month. This was twice the expected number and the biggest monthly jump in almost 30 years. The question whether it is the beginning of a sustainable rebound of just a temporary catch-up after weeks of frustrating lockdown remains open, but markets obviously appreciated. They were even more so delighted as the Fed Chairman confirmed a cautious outlook before the US Senate yesterday, which means that rates will remain lower for longer, and the liquidity tab will remain wide open. The Trump administration confirmed that it is working on a \$1 trillion infrastructure spending proposal.



An economic rebound, boosted by fiscal stimulus, with interest rates at 0 and the Fed buying financial assets, what could go wrong?

We are indeed confident in the recovery, but perplex on its shape and trajectory. More crucially, we are concerned about the fact that markets' elevated valuation creates vulnerability to any material bad news.

On the pandemic itself, the news are not great today. Beijing closed all its schools – which means, a lot of schools- and canceled 40% of outbound flights on concerns the recently detected cluster could expand rapidly. New cases in the US are not decelerating as much as expected, and even, rising in some states like Florida or Texas, while Brazil is approaching 1 million cases with no relief in sight.

Our scenario doesn't include a massive second wave as we believe that the world is much more able to handle the virus now. But this concern could impact confidence and cyclical markets, which is why we are now slightly overweight fixed income and underweight equities.

Geopolitical tensions are another topic. Indian and Chinese forces clashed along the Himalayan border in a deadly incident, which killed 20 Indian soldiers and an unknown, but probably comparable, number of Chinese soldiers. The two highly populated nations are blaming each other for the escalation, but indicate that they search a return to dialogue. North Korea is also a hot spot, less apparent than when Mr Trump was amplifying it on Twitter, but still: the country is sending forces in the demilitarized zone, calling them police and not army.

With such a backdrop, no surprise that the early hours of trading in Asia are less euphoric than yesterday. Asian stocks are slightly in the red, as are the US futures, while the dollar is edging up and Treasuries are sought after.

To summarize the situation, positive economic data and continuous support from policy measures are still pushing the remaining bearish investors to cover their bets before the end of the quarter. It could last until then, but we don't think we should buy into this rally: there could be opportunities to come back at more reasonable valuations later on.

Today we will get inflation data from Europe, as well as Russia GDP for the first quarter. The OPEC will publish its Oil Market Report and hold its Joint Technical Committee.
