



CIO OFFICE MORNING MARKET WRAP – Tuesday October 20th, 2020. ALSO AVAILABLE ON ALEXA.

Markets retreated from early gains driven by hopeful news about pre-election US fiscal stimulus to close in the red. Indeed, House Speaker Nancy Pelosi set a deadline of today to reach a deal and the US President weighed in saying that he is ready to match the spending level demanded by the Democrats and go even higher. Yet, if one compares that level, \$2.3trn, with what Republicans are ready to accept, a mere \$500bn, how can one even think of thinking that that chasm can ever be bridged, and in a matter of two weeks before the elections? And, since differences between the two sides are not only limited to the price-tag but extend to other issues, it is well worth that we turn attention to more salient matters.

Brexit talks are on life support as well following Boris Johnson's declaration that the UK should get ready to leave the EU without a trade deal, although the EU chief negotiator said that his team is ready to intensify work on a trade agreement. There are only four weeks left to agree on common ground, as a deal would need to be ready for the ratification process in Westminster and the European parliament. Equity investors seem to be pretty doubtful about that, with the FTSE 100 sitting, excluding dividend reinvestments, below the levels reached during the 2000 dot-com bubble and the 2007 sub-prime frenzy.

The positive news for the day was, in a way unsurprisingly, the economic release from China, where both retail sales and industrial production showed continued gains and confirmed the solidity of the economy. On the virus front the media continue to keep tally of new infections and people, even governments, get alarmed at the progression. Yet, a deeper look at the data shows that this second wave is far from being as lethal as the first one, avoiding that healthcare systems become overwhelmed.

New restrictions adopted in Europe simply based on the optics of rising new cases may prove to be a political mistake jeopardizing the recovery in the common area. Equities are not far removed from the highs of the year with a view gaining consensus that a clean Democratic victory will occur. Yet, a Democratic sweep represents only one scenario and much else can happen and cause disappointment.

For instance, in the case of a divided Congress, no president would likely be able to push through big fiscal measures, given the Republican minority firmly opposing them. Also, a so-called blue wave, with Democrats winning more seats even in the House and the agenda possibly shifting more radical, could constitute a market unfriendly outcome. In that case long-term gains from Big Tech would eventually fall victim to antitrust rhetoric. Voters still undecided about how to cast their ballots will be looking forward to the final presidential debate taking place on Thursday, with both Biden and Trump going live in Nashville.
