



CIO OFFICE MORNING MARKET WRAP – Tuesday September 29th, 2020. ALSO AVAILABLE ON ALEXA.

Yesterday was great on global markets. Developed market stocks added 1.3% with Europe and the US outperforming, while emerging markets gained 0.2%, with GCC doing slightly better. Interest rates were broadly unchanged. Gold added 1% and the price of Brent crude oil moved up 1.3% to \$42.5, both being helped by a 0.1% weaker US dollar. We like to think that some institutional investors are taking the opportunity of the current volatility to reduce their under-exposure to risk assets before the end of the quarter.

There was indeed no single event justifying such an optimism, even if improving prospects for fiscal stimulus made headlines. For sure, fiscal stimulus talks are going on in Washington, and Democrats released an amended \$2.2 trillion proposal which is closer to the Republican plan of \$1.5 trillion, but differences remain, and there is no way this could be passed before tonight's first presidential debate. This would at least be a more relevant topic for the debate than Mr Trump's tax records or Mr Biden's mental acuity. With regards to market perception, a debate winner being announced should not be a catalyst, but any sign that Mr Biden's intentions to raise taxes are not radical could be a positive.

On the virus front, the world is still struggling to contain the pandemic: global confirmed deaths sadly hit the 1 million mark and warning signs are still flashing in India as well as in the West ahead of the winter. ECB President Christine Lagarde addressed European lawmakers and reiterated that the central bank is ready to roll out more stimulus if needed. It's not a surprise, but it doesn't hurt. At the same time, Brexit talks have resumed in Brussels, with a UK Conservative Party rebellion over Mr Johnson's coronavirus powers as a backdrop. The US is considering new sanctions on Iran's financial system, in a move aiming at isolating further Tehran from global trade – Mr Trump certainly wants to reinforce its stance as Mr Biden promised to re-enter the 2015 nuclear deal if he becomes president.

As we write this morning, financial markets are only moderately positive in Asia. Japanese index prices are actually slightly down, but this is due to dividend distribution. Chinese markets add 0.5% in thin volumes, and Korea adds 0.8%. The dollar holds yesterday's losses, and Oil future contracts are down 0.4%.

There is no major economic release today but we'll look at consumer confidence in the Eurozone at 1PM and in the US at 6PM, before turning to the debate tonight
