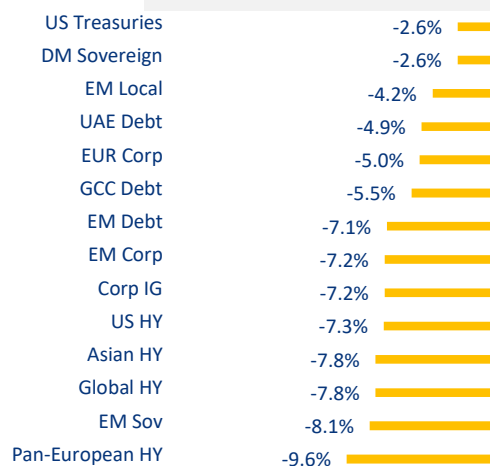




Today's Highlights

- **Virus Update:** Total fiscal and monetary support reaches USD 1.9 trillion across the globe according to Bloomberg; Wuhan sees zero new cases; Europe becomes the new epicentre crossing total number of infections in China
- **FED sets up Money Market Mutual Fund Facility** with Treasury Department providing USD 10 Bn of protection to avoid panic redemptions
- **BOJ offers to buy 300 Bn Yen 5-10 Year Japan Govt Bonds**
- **RBA cuts benchmark rate to 0.25%**, announced 3-year gov't bond yield target of c. 0.25%, sets up a term funding facility of USD 50 Bn for banking system to help credit growth for SMEs and term repo operations to infuse liquidity. Earlier 10-Year Australian Gov't yields rose by 1.28% in a massive move before coming down post RBA's announcement
- **ECB announces launched 750 Bn Euro bond buying program** that covers all eligible assets under the current QE as well as Greece Gov't Bonds; France to let banks tap capital buffers freeing 8 Bn Euros
- **Bloomberg dollar index climbs to all time high** while all the Asian markets in red this morning.
- **Gov't benchmark bond yields increase across the world** with US 10-Year Treasury yields at 1.24%
