



CIO OFFICE: Equity Market Update 28th July 2020

Developed Markets

- ✓ U.S. stocks climbed, led by technology shares on speculation the Federal Reserve will reinforce its dovish message. The S&P 500 erased last week's drop as the rebound in tech overshadowed a slide in banks. The S&P 500 index was up +0.74% on Monday.
- ✓ European stocks declined with travel shares leading the decline after Britain imposed a two-week quarantine on travelers returning from Spain after a surge in coronavirus cases. The Stoxx 600 index is down -0.31% on Monday.

Emerging Markets

- ✓ Chinese stocks edged higher on Monday, supported by positive economic data and gains led by metals and mining companies. The Shanghai Shenzhen CSI 300 index was up +0.51% on Monday.

GCC

- ✓ The DFM index rose for the second day, climbing +0.1%. Damac Properties contributed to the DFM index gain, increasing +8.3%. Arabtec Holding saw the largest jump, increasing +14.9%. Arabtec stocks surged this month, increasing share price by +95%. All Emaar stocks fell. Emaar Properties -1.9% Emaar Development -0.5% Emaar Malls -0.7%.
- ✓ Commercial Bank of Dubai reports AED 530 mn net profits 1H20, down -24.3% YoY. Impairment allowances were AED 495 mn for 1H20 up +30% compared to the same period in 2019.
- ✓ The Abu Dhabi General Index increased +1.06%, with FAB contributing the most to the index gain, increasing +2.6%. 2Q20 results for FAB and ADCB are set to be announced in the coming days.
- ✓ Tadawul All Share Index rose +0.3% with material stocks that led the market higher. Saudi Basic Industries Corp contributed the most to the index gain, increasing +1%.

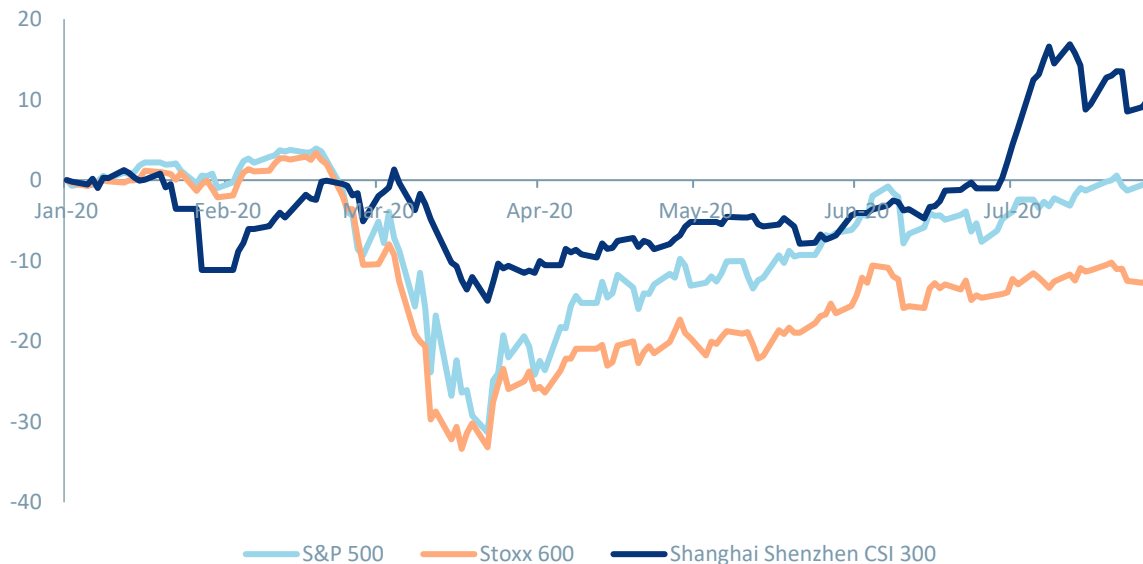
- ✓ **TSMC's** USD 35 bn rally puts Taiwan Stock Index above 1990 peak. The Taiex closed 2.3% higher Monday as TSMC hit the 10% daily limit. The \$35 billion addition to its market capitalization makes TSMC the 12th most valuable stock worldwide, ahead of U.S. retail giant Walmart Inc.
- ✓ **SAP** will keep a majority in the business after the U.S. listing, which in turn will make Qualtrics co-founder Ryan Smith the biggest single shareholder, the company said late Sunday. An IPO could value Qualtrics, which measures and generates reports on customer and employee satisfaction, at as much as EUR 16 bn (USD 18.7 bn), according to Bloomberg Intelligence analysis, more than twice what SAP agreed to pay in late 2018 in its biggest-ever acquisition.
- ✓ **AstraZeneca** agreed to pay as much as USD 6 bn to buy into Daiichi Sankyo Co.'s promising medicine for lung and breast cancer, the drugmaker's second potential blockbuster oncology deal in two years.
