



### CIO OFFICE: Equity Market Update 30<sup>th</sup> April 2020

#### Developed Markets

- ✓ U.S. equities surged on hopes for a virus treatment. Findings showed that Gilead's Remdesivir offered promising results and the company issued a statement stating that the NIAID's trial on Remdesivir showed patients that take the drug recovered faster from COVID. Additional details on the trial are expected later today. There is also a global push for vaccine preparedness by the end of the year
- ✓ The U.S. GDP report for Q1 showed the largest economic contraction -4.8%, since the credit crisis of 2008 and a significant fall in consumption
- ✓ The FOMC meeting left rates unchanged at a target range of 0-0.25% while also reiterating that the FED will use whatever tools available to support the economy
- ✓ The U.S. 10yr yield climbed to 0.63%. WTI Crude, +22% for the June contract. Gold finished down 0.5%. The USD was weaker vs the Euro, Yen, and Pound. The Dow Jones Industrials closed +2.21%, S&P 500 +2.66%, NASDAQ +3.57%, and Russell 2000 +4.84%. European equities also saw a rally with the Eurostoxx +2.3%
- ✓ In the US: Growth +3.20% outperformed Value +1.96%. Nine sectors finished higher for the day while two finished lower. Energy +7.35% was the top-performing sector, while Utilities -0.92% was the weakest performing sector

#### Emerging Markets

- ✓ Asian markets are up this morning. China remains in the lead amongst major global indices year to date with the MSCI China -4.8%. Indian equities are headed for their first monthly gain this year, Sensex + 2.8% yesterday

#### GCC

- ✓ UAE indices had a positive close continuing a week-long rally. The Abu Dhabi government plans to allocate 15% of its procurement budget to SMEs to boost them in the aftermath of the pandemic

#### Company News

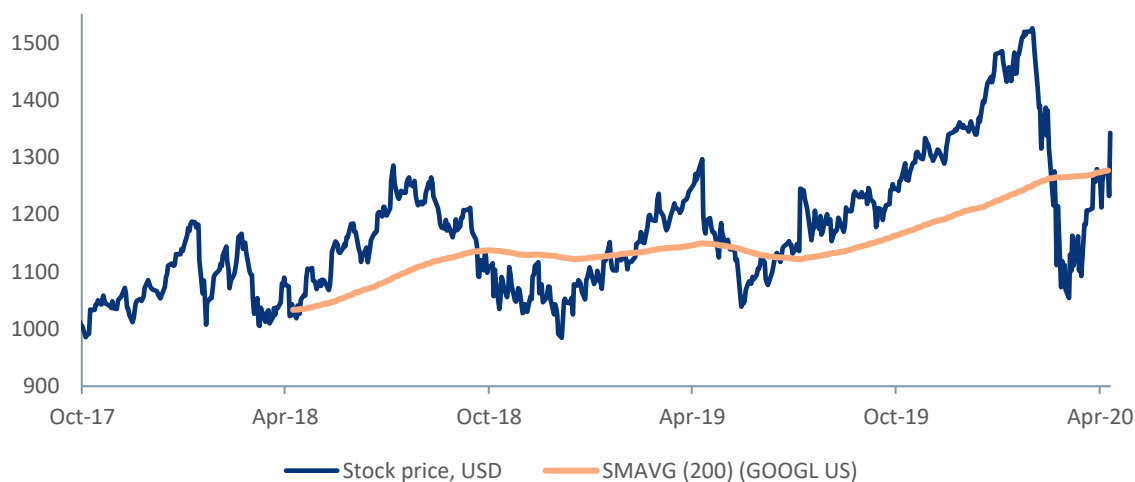
- ✓ **Facebook** reported an 18% surge in Q1 revenue and said business remained steady in the first few weeks of April.
- ✓ **Chevron** maintained its quarterly dividend forecast at USD 1.29 per share
- ✓ **Volkswagen** Q1 Profit Falls; Deliveries Down 23.0% y/y. First-quarter sales revenue declined by 8.3% to EUR 55.1 bn. Similar results from Daimler with vehicles sold down by 17% in the first quarter
- ✓ **Northrop Grumman** missed analyst expectations on EPS. Guidance for 2020 is a 3-4% growth
- ✓ **General Dynamics** reports lower profits and sales y/y. However, Aerospace backlog was up 9% Y/Y to USD 1.1 bn, and defense sales were up slightly on the year to USD 7.1 bn. Coronavirus-related travel restrictions and delayed deliveries of business-jet aircraft took a USD 549 mn revenue bite from the Aerospace segment
- ✓ **Mastercard** 1Q beat estimates with EPS of USD 1.83 +6% y/y, spoke of an increase in contactless payments
- ✓ **Airbus** reported Q1 consolidated net loss EUR 481 mn, (last year's profit EUR 40 mn) due to the coronavirus. Loss per share was EUR 0.61, compared to EPS of EUR 0.05 a year ago. Airbus will continue to focus on cash preservation as it burnt through EUR 8 bn of cash in Q1 and spoke of a record slowdown in deliveries
- ✓ **AstraZeneca** reported Q1 core EPS of USD 1.05 +21% y/y due to higher revenues boosted by medicine stockpiling amid the coronavirus pandemic. Total revenues were up 16% to USD 6.35 bn, driven by higher product sales
