### OBJECTIVES AND INVESTMENT POLICY

#### Investment Objective

The sub-fund aims to achieve a high level of income as well as capital growth, predominantly through a diversified portfolio of MENA (Middle East & North Africa) debt securities of varying maturities along with cash and cash equivalent instruments such as money market funds with efficient portfolio management. The sub-fund may also take on exposure to issuers outside the MENA region.

#### Investment Policy

For this purpose, the sub-fund:

- invests up to 100% of its assets in fixed and floating rate securities which shall be principally, but not limited to, MENA markets;
- may take exposure to non-MENA securities up to a limit of 30%;
- may hold cash and cash equivalents;
- may invest in collective investment schemes.

The sub-fund will not invest in any underlying fund with an annual management fee in excess of 2%.

The sub-fund may invest in financial derivative instruments for hedging purpose.

#### Benchmark

The Sub-Fund is managed actively and uses the JP Morgan MECI GCC Total Return index as a universe to select securities from. The deviation of the portfolio composition of the Sub-Fund compared to the benchmark is material.

#### Investment Horizon

Recommendation: This sub-fund is not suitable for investors who plan to withdraw their money within 3 to 5 years.

#### Income

Income generated will be reinvested.

#### Fund Currency

The reference currency of the sub-fund is USD.

#### Subscription and Redemption

Investors may subscribe, convert and redeem shares on demand on a daily basis, being a valuation day, as further determined in the prospectus of the fund.

### RISK AND REWARD PROFILE



#### Risk Disclaimer

The risk and reward indicator illustrates where the sub-fund is positioned in terms of its possible risk and reward. The higher the sub-fund's position on this scale, the greater the possible reward, but also the greater the risk of losing money. Even if the sub-fund is in the lowest risk class you can lose money as no investments are entirely risk free. The risk indicator is calculated using historical data and therefore cannot be used as a prediction for the future. The risk classification may change over time.

#### Why is this Sub-Fund in this category?

The sub-fund is subject to a medium level of risk as it is exposed to market factors such as global macro-economic trends, currency fluctuations, interest rates fluctuations, inflation and the performance of issuers of securities. At this time the level of the risk and reward profile is equal to 4.

#### The risk and reward indicator does not take into consideration the following risks, which can affect the sub-fund:

**Credit risk** - The possibility that a debtor will not meet their repayment obligations.

**Operational risk** - Which may occur due to technical issues for example natural disasters, misunderstandings and fraud.

**Derivative risk** - Use of derivatives results in higher chances of loss due to the use of leverage, or borrowing. Derivatives allow investors to earn large returns from small movements in the underlying asset's price. However, investors could lose large amounts if the price of the underlying moves against them significantly.

**Emerging markets risk** - In emerging markets the legal, judicial and regulatory frameworks are still developing so there could be, for local market participants and their counterparties, a high degree of uncertainty.

**Sustainability risk** - Which may occur because the Sub-fund does not promote ESG Characteristics and Sustainability Factors and does not maximize portfolio alignment with Sustainability Factors.

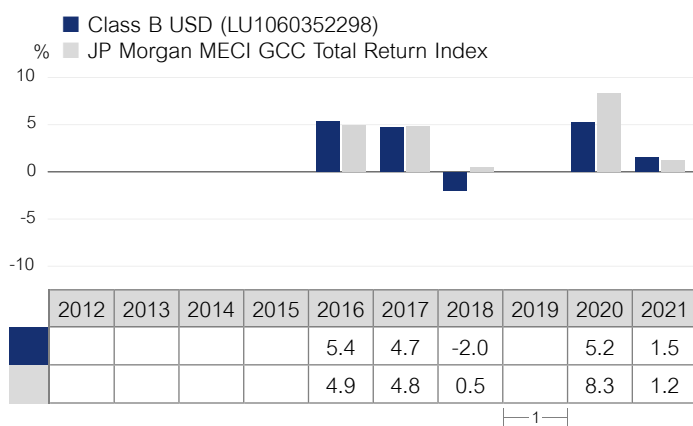
The ongoing charges may vary from year to year and include investment management, management, administration and custodial fees. They do not include portfolio transaction costs and performance fees.
